The Planning Commission held a public meeting regarding the rezoning of the Potter property from Ag to RR. After reviewing Article X, the Planning Commission approved the rezoning. Parks and Recreation Report: Ms. Collard gave an oral report on the Parks and Rec Committee. A grant has been submitted to the Michigan Health Department for a greenspace at Hayes Township Park. A Charlevoix 2nd grade class submitted letters in support of the greenspace grant. The Parks and Rec Committee is interested in the Township purchasing a computer program that will allow the committee to manipulate different layouts of the park to plan for future development.

Mr. Jess made a motion for a software allowance up to \$500.00 for park planning, with support from Mr. Cunningham. A roll call was taken.

The Township is still waiting to hear back from the Tribe regarding road money. Supervisor VanZee invited Fred Parsons to speak. Mr. Parsons presented the Township with a shovel his father HE had received from Big Rock while he was supervisor and felt it should be returned to the Township.

Web Page Proposal Review: Ms. Collard presented a breakdown of the four webpage proposals the Township has received. Web companies and proposals include: Revise (did Charlevoix County website), Town Web, Common Angle (local company) and current webmaster Omiemedia. Ms. Collard stated the township's appreciation of Omiemedia's work, but the township needs to cut back on expenses.

Ms. Collard made a motion, supported by Mr. Nugent, to accept Webpage proposal from Common Angle for a cost of \$3,400 for the first year and \$714.00 for each additional year of a four-year contract. A roll call was taken.
