**EASTERN AVE. BEACH CLEAN UP** – The Pine Point Association is having a beach clean up at Eastern Ave. Beach Sunday July 1. The Association is willing to pay \$500.00 towards having Sandtastic groom the beach again this year.

Marlene Golovich made a motion, supported by Paul Hoadley to hire Santastic to groom the beach one time this summer and authorize a payment of not to exceed \$800.00 from the Township with a payment of \$500.00 from the Pine Point Association to pay the fee of \$1,300.

<u>TREASURERS REPORT</u> – Robbin Kraft stated that she and Patty are working on the summer tax bills.

#### **TRUSTEE REPORT** – No Report

<u>SUPERVISOR REPORT</u> – Ron stated he thought some of the proposed fund balance should be put back into some of the items removed from the Phase I construction. He would like to see conduit laid under the roads for future water, sewer and electric and the 2<sup>nd</sup> wall put in at the launch. Ron will get a price from Cunningham's to see if there is a substantial increase in cost waiting to put the wall in next year after applying for a grant. Marlene and Ron will meet with Performance Engineers to talk about getting conduit put back in the project before the construction begins.
