<u>PUBLIC COMMENT</u> was taken on change order, revenue budget, listening to residents, adding in project costs, future plans, smaller launch, borrowed money, additional millage, going back to the drawing board.

JULY MEETING DATE CHANGE – Robbin Kraft made a motion, supported by Paul Hoadley to change the July regular meeting date from July 9, 2018 to July 16, 2018. Motion carried.

<u>ACCOUNTING</u> – Marlene Golovich made a motion, supported by Matt Cunningham to hire Vel Kammermann to assist the township with establishing a new fund for parks and recreation, setting up chart of accounts and assisting with setting up the budget for the new parks and recreation fund and to authorize the clerk to sign a contract for the hourly rate established by Vel Kammermann.

<u>**CAMP SEA-GULL PHASE I CHANGE ORDER**</u> – Supervisor VanZee stated that based on the proposed fund balance at the end of this project he and the Clerk met with Performance Engineering to discuss adding in items previously removed from the Phase I project at Camp Sea-Gull. The items were not required by the granting agencies but are important to future projects in the park and if they are done at a later time will cost considerably more money. One of the items was a 2^{nd} wall but it was determined via Matt Cunningham that it would not be **costlier significantly more** to add it at a later date so the township could apply for grant money to do the work. Other items of concern were the conduit for water, sewer and electrical. Performance Engineering prepared a spread sheet with costs (see attached) for conduit, barriers, plantings etc. for the Board to consider. The board considered future planning, prices now versus later and safety.

Paul Hoadley made a motion, supported by Robbin Kraft to add in items from change order #1 (see attached) 58, 58A, 59, 60, 61, 62, 63, 64, 65, ½ of 92 totaling \$58,262.00 and authorize Supervisor VanZee to sign the contract.
