## HAYES TOWNSHIP BOARD SPECIAL MEETING MINUTES March 22, 2017

The special meeting of the Hayes Township Board was called to order by Supervisor Ron VanZee at 7:00 p.m. at the Hayes Township Hall, 09195 Old US 31 N., Charlevoix.

**ROAD WORK** – Paul Hoadley made a motion, supported by Matt Cunningham to ask the Road Commission to put the following road work out for bids; 0.59 miles (3,100 ft) of Bayshore Streets – Townline & Division Streets, engineers estimate of \$131,325.00 and 1.00 miles (5,280 ft) of Quarterline Road from Boyne City Road south to Road End engineers estimate of \$212,480.00.

<u>PARK HOST</u> – Marlene Golovich made a motion, supported by Matt Cunningham to offer the park host position to both applicants the Lauchers and the Stauffers. Motion carried. The Board with the Parks and Recreation advisory committee will make a list of expectations for maintenance projects for the host families.

Public comment. This is a gift to have two families. Has any thought been given to hiring a park director. We need more events. The park is a great resource.

The Township will seek a legal opinion on what portions of an employee's records are subject to the Freedom of Information Act.

<u>FUND RAISING</u> – Jen Booher an Independent Contractor/Consultant presented the Township with a proposal to help with fund raising for Camp Sea-Gull. The fee for this service is \$25,000.00. Before deciding to accept or refuse the proposal the Township will seek additional funding opportunities to pay for this service.

<u>DRY HYDRANTS</u> – The property owners of MI Heights and the Charlevoix Township Fire Dept. are working together to repair the dry hydrants in the trailer park. Matt Cunningham will be coordinating with the Fire Dept. to locate all dry and wet hydrants within the Township and create a report with location of the hydrants and whether they are working or not.

Public comments. What can be put out in the spring clean-up. The list tells what cannot be put out but not what will be picked up. Make a list of items that can be picked up and post it on the web page.
