RECREATION PASSPORT GRANT – Ethel Knepp made a motion, supported by Jim Rudolph to adopt the following resolution.

WHEREAS, Hayes Township Board of Trustees supports the submission of an application titled, Hayes Township Park –Camp Sea-Gull Cabin Project to the Recreation Passport Grant Program for the renovation of existing cabins to make the foundations safe and the cabins ADA compliant at the Hayes Township Park – Camp Sea-Gull; and,

WHEREAS, the proposed application is supported by the Community's 5-Year Approved Parks and Recreation Plan; and,

WHEREAS, Hayes Township has made a financial commitment to the project in the amount of \$15,000.00 matching funds, in cash and/or force account; and,

NOW THEREFORE, BE IT RESOLVED that the Hayes Township Board of Trustees hereby authorizes submission of a Recreation Passport Grant Program Application for \$45,000.00, and further resolves to make available it financial obligation amount of \$15,000.00 (25%) of a total \$60,000.00 project cost, during the 2016-2017 fiscal year.

WHEREAS, Hayes Township Board of Trustees supports the submission of an application titled, Camp Sea-Gull Access Road and Boat Launch to the Land and Water Conservation Fund for development of an Access Road and Boat Launch at Hayes Township Park – Camp Sea-Gull; and,

WHEREAS, Hayes Township has made a financial commitment to the project in the amount of \$1,026,705.00 matching funds, in cash and/or force account; and,

WHEREAS, if the grant is awarded the applicant commits its local match and donated amount from the following sources:

Hayes Township General Fund \$533,305.00 Charlevoix County \$10,000.00 DNR Waterways \$483,400.00

Total \$1,026,705.00

NOW THEREFORE, BE IT RESOLVED that the Hayes Township Board of Trustees hereby authorizes submission of a Land and Water Conservation Fund application for \$150,000.00, and further resolves to make available a local match through financial commitment and donations of \$1,026,705.00 (87%) of a total \$1,176,705.00 project cost, during the 2016-2017 fiscal year.

ZONING ADMINISTRATOR REPORT – Larry Sullivan provided a written report and oral overview. Ethel stated she talked to the Township attorney regarding the issue with the old Forest Cove PUD and the rental house on Woods Creek. The attorney suggested she write a letter to the owner and listing agent for the rental on Woods Creek and notify them they are in violation of the ZO. Paul stated that he would be working with the ZA regarding the shoreland protection violations.

<u>PARKS AND RECREATION REPORT</u> – Ethel stated that she received notice that Leslie Cunningham has resigned from the P & R Committee. Paul Hoadley made a

motion, supported by Robbin Kraft to accept the resignation of Leslie Cunningham from the Parks and Recreation Committee.

<u>REPORT FROM PLANNING COMMISSION</u> – Jim reported that the PC will be doing a site plan review for Subaru by the Bay at the March 22 meeting. The PC reviewed the proposed letter to area landscapers.

Suggested items were elections items and announcements about parks such as the settled lawsuit at EAB. Jim also stated that a representative from Disability Network is meeting him at CSG to address ADA issues in the cabins. Jim stated the folks from Pipeline 5 may be contacting the Township regarding our position on the pipeline.

ASSESSOR REPORT – The Roll is complete.

<u>COMMISSIONER LASATER</u> – The ribbon cutting ceremony for phase 1 of the non-motorized bike trail is March 8, 2016 at Young State Park. George stated they are working on the roll back of the general fund millage to offset the collected parks millage.
