It has come to the Board's attention the importance of incorporating a different method of township email accounts/backup system and electronic record storage. Board of Trustees will follow up with a firm proposal.

PARKS AND REC BID REQUESTS

Board of Trustees came to a census to grant the Parks and Rec permission to go forward with discussion and proposals for improvements at Hayes Township Park.

PARK HOST: BECKY AND GREG'S END OF SEASON

Greg wanted to thank the township for allowing Becky and he to care for Hayes Township Park again this year. He also shared with the board suggestions from park visitors for the park. The most common has been requests for grills for the park as well as steps to enter

HAYES TOWNSHIP POSITION ON THE LAW PROPERTY Mr. VanZee spoke regarding the Township's position on the Law property decision. PUBLIC COMMENTS: Public comments opened at 8:12 pm. Comments include:

- * Enormous resources for shoreline protection in Hayes Township
- * Watershed Council has questions regarding moving forward on permit process (will permit have to be renewed/reviewed)
- * Watershed Council recommends the permit be denied as proposed but notes the applicant has been opened to modifying the plans per recommendations
- * VanZee noted the permit was issued with conditions that have not been met yet and any modifications or suggestions that affect the permit would be reviewed
- * Opposition to the project and notes this is another huge project that digs into shoreline/Camp Seagull

- * Township could bring to attention of residents all large projects
- * Request to Township to revisit the approval and rescind approval
