Whereas, the ARPA funds will be distributed in two equal disbursements, with the first direct deposit by November 01, 2021, and the second direct deposit approximately 12 months later; and Whereas, it is recommended by federal and state agencies that the ARPA funds be held in a separate and distinct revenue fund from the General Fund to ensure accurate accounting, monitoring and reporting of ARPA funds.

Now, Therefore, Be It Resolved, the the Township of Hayes, Charlevoix County, establishes and assigns said FUND with a description of "ARPA FUNDS" and directs the Clerk-Treasurer to open a separate account at CHARLEVOIX STATE BANK, Charlevoix, Michigan, and to set up said revenue fund in the accounting software and follow the State of Michigan Treasury Department account structure for governmental funds.
