SHORELAND SUB COMMITTEE: Marilyn Morehead presented an oral report. The Shoreland Sub-Committee visited two properties with principal structures being worked on. The first property is more than 100 feet from the lake, currently almost all lawn down. Shoreland Committee is recommending 25-30 feet of native plantings. The second property is a steep slope to the lake. The proposed plan is acceptable with an additional buffer on the north side of property.

The new ordinance will be broken up into articles reflecting the following: Title and Purpose, General Provisions, Zoning Maps and Districts (each district will have a specific map and tables for ease of understanding), Overlay Districts, Site Development Standards, Supplemental Use Standards, Site Plan Review, Special Land Uses, Land Development Options, Nonconformities, Zoning Board of Appeals, Administration, Enforcement & Violations, Amendments & Severability, Definitions and possible additional considerations. Subcommittees have been created to provide feedback (Open Space: Farm & Forest/Doug Kuebler; Waterfront Development Regulations: Marilyn Morehead; Development Construction: Ed Bajos)
