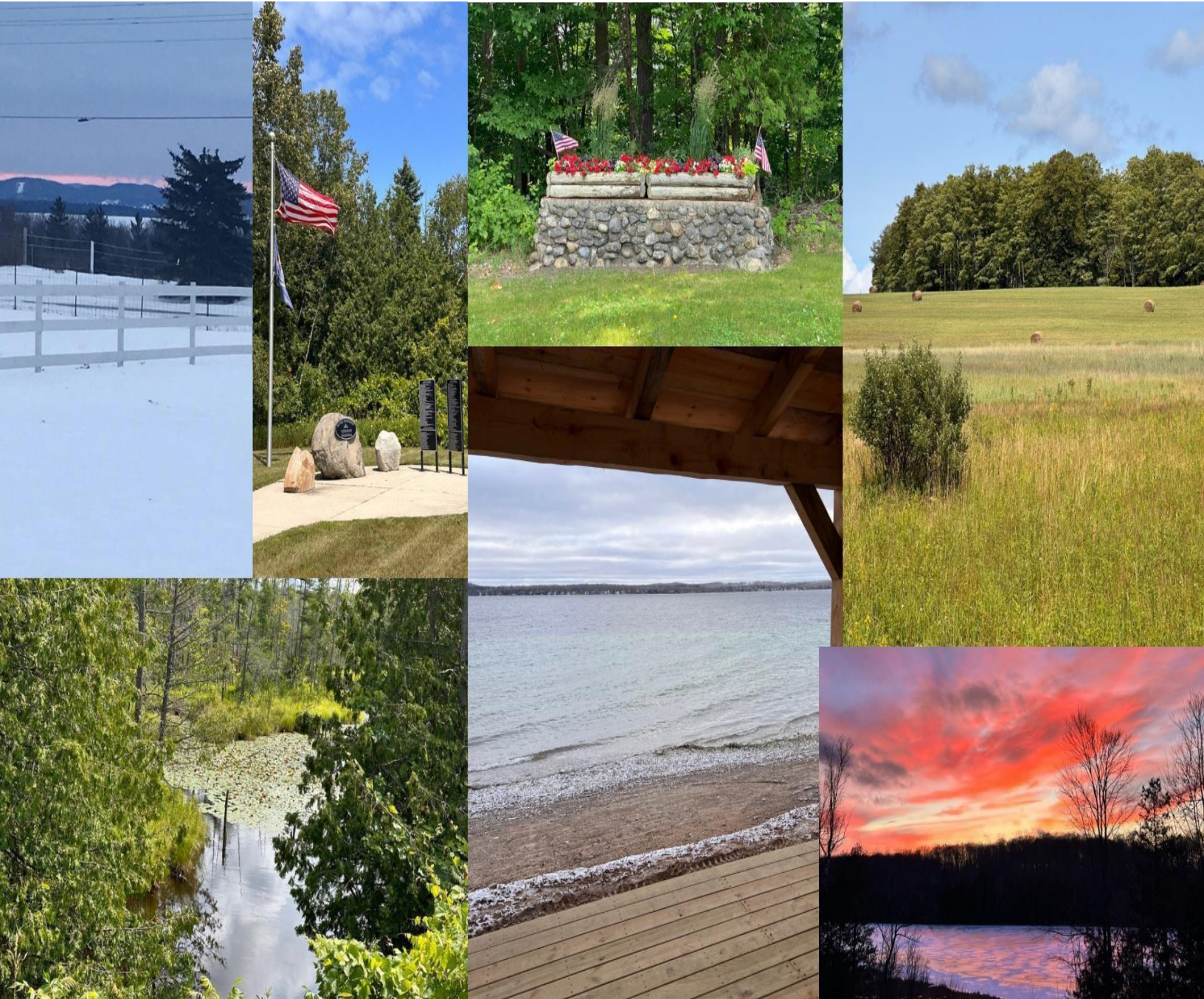

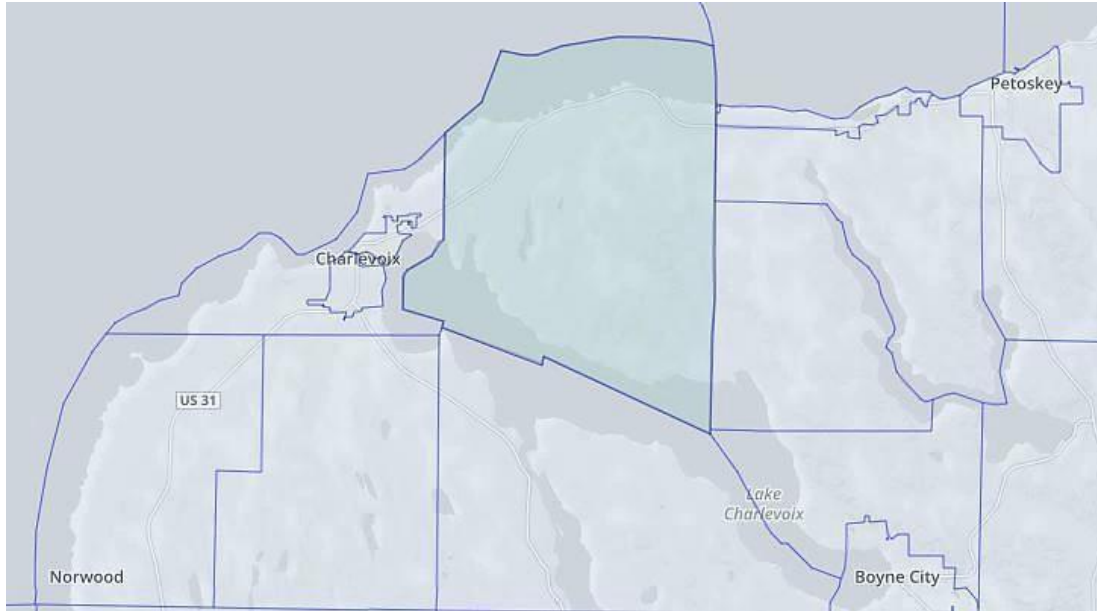
1.0 COMMUNITY DESCRIPTION

Introduction and Regional Setting

Hayes Township is positioned between the Cities of Charlevoix, Boyne City and Petoskey. It is bordered on the north by Lake Michigan, on the south by Lake Charlevoix, on the west by Charlevoix Township, and on the east by Bay and Resort Townships. Lake Michigan, Lake Charlevoix, Susan Lake, several streams, and many wetlands add to Hayes Township's unique character.

In the Township's interior, large parcels of agricultural and forest land are mixed with smaller residential parcels. At the Township's northern border, the area known as Bay Shore, developed around several commercial establishments, many of which are still operating. Hayes Township with its abundance of natural resources, is enjoyed for its many recreational opportunities.

Hayes Township is located along the shore of Lake Michigan between Charlevoix City, Petoskey City and Boyne City. The township extends to Lake Charlevoix on its southern border. According to the United States Census Bureau, the township has a total area of 43.2 square miles, of which 30.1 square miles is land and 13.1 square miles, or 30.29%, is water.

2.0 Recreation

The recreation opportunities in the Township currently consist primarily of water-related activities, boating, fishing, swimming, seasonal game hunting and non-motorized trails for walking, hiking, skiing, bicycling, as well as some trails for snowmobiling. There are public access sites on Lake Michigan, Lake Charlevoix and Susan Lake within the Township that are well utilized both in the summer and winter seasons. A network of trails in the Township utilizes both public and semi-public lands, such as the State land MDOT (right of way), Charlevoix community and the Little Traverse Conservancy properties.

The parks and hiking trails are highlights for nature enthusiasts to visit. There are two small lakes and three creeks found in the township. Horton Creek flows from the higher elevations in Bay and Hayes Township. The creek traverses the township to a point where it runs through Bay Township and empties into Horton Bay on Lake Charlevoix.

2.1 Susan Lake

Mud Creek flows from Mud Lake to Susan Lake. Susan Creek flows from Susan Lake into Lake Michigan just north of Big Rock Point. Preservation of Susan Lake is a priority of the Little Traverse Conservancy, which owns and manages 21.5 acres of shoreline property.

Each creek is bordered by wetlands that encompass significant acreage. Susan Lake is a shallow, extremely sensitive body of water well along in the growth of plants and algae, home to a variety of wildlife and fish.

2.2 Little Traverse Wheelway (LTW)

The Little Traverse Wheelway is a 26-mile, non-motorized paved trail that extends from Charlevoix to Harbor Springs. It was officially dedicated to the people of the State of Michigan on October 24, 2002.

Little Traverse Wheelway provides cyclists, inline skaters, walkers, runners, skiers, electrical bicycle and joggers with a smooth path, incredible scenery and a non-motorized link between three of the most popular resort towns in northern Michigan; Charlevoix, Petoskey and Harbor Springs. The Little Traverse Wheelway Non-Motorized Trail passes through Hayes Township along US-31. Snowmobiles and horses are NOT permitted anywhere on the trail.

The Little Traverse Wheelway Map in Hayes Township

Map 1.1 shows The Hayes Township segment of this trail is approximately 7.3 miles long and runs along the north side of US-31 from Charlevoix Township to the Charlevoix, Emmet County line at Bay Shore.

In Hayes Township, this trail offers a unique boardwalk bridging over a wetland area rich with wildlife, and direct water access at points along the Lake Michigan shoreline with two roadside parks for picnic & scenic resting spot with one having restrooms and two other roadside areas with small boat launches.

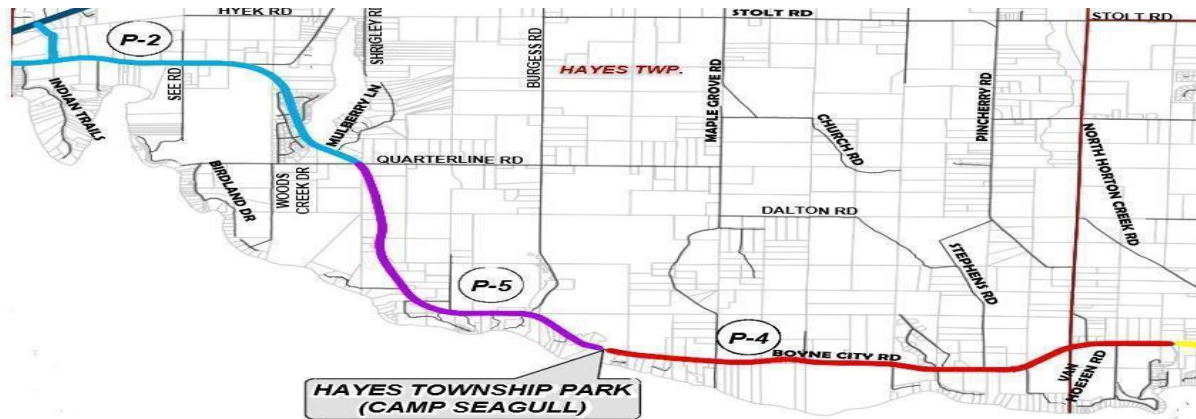


2.3 Boyne to Charlevoix Non-Motorized Trail

Most of the Boyne to Charlevoix Non-Motorized Trail runs through Hayes Township covering 8 miles. The total trail path is a paved 10-foot wide, approximately 14-mile-long trail, mostly detached from Boyne City Road. The trail will be constructed in five (5) phases. Phases 2, (completed) 4 and 5 run through Hayes Township. Phase 1, completed, is in Boyne City.

Map 1.2 shows the Non-Motorize Trail, that runs only through Hayes Township, Trails are colored. P2 in blue, P4 in red and P5 in purple.

This trail is intended for non-motorized recreational activities and non-motorized transportation between Boyne City and Charlevoix. Trail users may walk, bike, skate, or ski (pick your favorite sport for any season) on the trail. Snowmobiles and horses are NOT permitted anywhere on the trail.

Phase 2 begins at the Little Traverse Wheelway in Hayes Township, east of Waller Road, crosses US-31 and follows a series of easements across private property to Boyne City Road east of the Argonne Supper Club, and then runs parallel to, but separate from Boyne City Road within the road right-of-way on the north (Susan Lake) side of the road to Quarterline Road, southeast of Susan Lake, for 2.97 miles.

At the point where the trail meets Boyne City Road, a trail spur runs west within the right-of-way on the north side of the road to Eastern Avenue to create an access point for Pine Point Subdivision. Trail users can follow Eastern Avenue to Lake Charlevoix where there is public access with a picnic area and swimming beach. The trail continues the north side of Boyne City Rd through Hayes Township towards Boyne City.

Engineering and construction costs have been approved through Charlevoix County, through the support of Bay, Hayes, and Evangeline Townships, as well as Charlevoix County Trail team and Top of Michigan Trails Council, MDOT, Community Foundation, and other local grants. This renewed effort will continue in 2024. A trailhead is planned at Hayes Township Park Camp Sea-Gull for this path.



2.4 Golf Courses

The semi-public recreation lands in Hayes Township has two golf courses Dunmaglas Golf Course and Charlevoix Country Club and Fitness. Each provides scenic beauty, natural landscape, adjacent to nearby Lake Michigan and Lake Charlevoix.

3.0 Administrative Structure and Funding in Hayes Township

The Parks and Recreation Committee is made up of 6 area residents and one Board Representative, for a total of 7 members. They meet monthly, with additional meetings scheduled as needed.

The Parks and Recreation Committee board representative reports directly to the Hayes Township Board of Trustees and requests support and/or approval for their projects.

Updates to the Hayes Recreation Master Plan will be reviewed by the Hayes Township Planning Commission as well as the Hayes Township Board of Trustees for input and recommendations.

Routine park maintenance will be handled by the Township staff, contractors and volunteers operating under the direct authority of the Township Board. The final financial decision-making authority and responsibility for all park related projects resides with the Township Board.



3.1 Volunteers

Volunteers are an integral part of recreation projects in Hayes Township. Volunteers are solicited on a project-by-project basis to provide some of the labor for the Township “in-kind” match on projects as appropriate. For lake related projects, the Lake Charlevoix Association and other local groups are consulted on the proposed project.



Relationships

This recreation plan covers Hayes Township, which includes portions of three school districts. Most township children attend Charlevoix Public Schools. The eastern portion of the township is within the Boyne City Public School District. The Bay Shore area is within the Petoskey Public School District. Additionally, some students from the township attend area private schools or public charter schools in Charlevoix, Boyne City and Petoskey.

Hayes Township works cooperatively with the Top of Michigan Trails Council and Charlevoix County to continue to pursue the development of non-motorized trails along the Boyne City-Charlevoix Road and bike lanes and/or other roads to effectively develop local routes that connect with larger trail systems in Northern Michigan. Phases 1 and 2 of the non-motorized trail system are completed, and Phase 3 will be completed in 2024. The Hayes Township Master Recreation Plan has included a major trailhead for this path at Hayes Township Park Camp Sea-Gull. It is in an ideal location for bike racks, access to water, sheltered area, bike repair station, and other possible future amenities.

Charlevoix County has their own adopted recreation plan. Hayes Township maintains their own separate Recreation Master Plan, as do other local townships. The Hayes Township Recreational Master plan is available for all local municipalities to review.

3.2 Parks and Recreation Budget & Funding

Hayes Township Fiscal year runs from July 1-June 30th. Each spring, the Board of Trustees has a Budget workshop and, with the input of the respective committees and commissions, constructs a budget draft for the following fiscal year. A budget hearing is held before the June Board Meeting to allow for review/editing of the proposed budget. The final budget is then adopted at the regular June Board of Trustee meeting.

3.3 Breakdown of Expenditures

Hayes Township Park Camp Sea-Gull is the largest park in the Hayes Township recreation inventory at 20 acres. It features an upper section of the park, where the main entrance is located, a host house for our seasonal park hosts to reside, as well as a lower waterfront park area with parking, boat launch, fishing pier, picnic area, covered pavilion, grills, and a fire pit.

The park was acquired as a former summer camp, with several sections of the park that will be re-purposed and create new amenities for visitors. There is a year-round need to care for and maintain several park features. These include, but are not limited to, cleaning and pumping of vault bathrooms, removing and installing skid pier, set up and monitoring of bubblers by the pier, and the removal of trees that pose safety issues for park visitors.

Phase I Construction in 2019 added a new entrance, parking lot, boat launch, fishing pier, and vault bathrooms. There were several unexpected costs that came with the new construction that had not budgeted for: fencing along the shale wall in the lower parking area, fencing along the upper edge of the park where there is a very steep slope, and additional railing along the fishing pier/boat launch area. These expenses were absorbed by the bulk of the Parks and Rec budget for those years. There is one more large project, proper drainage set up in the lower part of the park that will need to be addressed before moving forward with completion of the plans shown in the park rendering. The Board of Trustees is discussing a plan of how to pay for these repairs.

The Parks and Recreation Committee is committed to working toward adding amenities that best serve our community. The Charlevoix Millage Grants (described in 3.6) are a yearly granting opportunity that Hayes Township has been successful in being awarded each year. They propel our park amenities forward and add true value to all visitors who are able to enjoy new additions each year.

The remaining park budget is for our other smaller park areas. Each year, the needs of all parks are discussed and identified. The Committee also discusses grant opportunities that the township may be able to benefit from.





3.4 Fundraising Efforts

Hayes Township has a Fundraising Policy in place. It clearly spells out how donations will be used. There is an additional policy for Amenity Donations made to the Township, as well as separate donor Application. The Parks and Recreation Committee is working to compile more opportunities for Residents and community members to make a donation and impact the growth of our park amenities. Donations for items such as engraved bricks will financially assist the Township for the current project, as well as create a touchstone for visitors to view and share with loved ones when they visit the park. This extends to benches, picnic tables, nature signage, as well as larger amenities, i.e. playground, Pavilion, amphitheater. All level donations will be accepted to make our parks a point of pride for the entire community.

Hayes Township Donation & Fundraising Policy

Financial support from the community is integral for any township project. The bulk of community support should come from fundraising and grant funds. All funds collected will be kept in earmarked restricted township accounts. The township encourages cash donations but will consider in-kind donations on a case-by-case basis. General financial gifts will be used at the discretion of the township. Funds received from donations for a specific designated fundraising amenity (pavilion, playground, pickleball courts, etc.) will only be used for that item and be kept separate.

*No amenities in any form may be placed or installed on any Township grounds.
All amenities must be approved, and placement arrangements made by Township officials.
Anything placed without approval will be removed.*

Donor Conditions:

Donations must be given unconditionally and voluntarily. Township employees and officials cannot receive personal benefit from any donation, nor can the donor expect benefit beyond what the program specifically provides.

A donor may wish to remain anonymous, however, the Township would require the donor's name and contact information to issue a tax receipt. The donor's private information will be treated with confidentiality within the extent of the law, state and federal guidelines, unless the donor authorizes release of such information for a specific purpose.

The township may accept or decline any donation in its sole discretion.

All donations will be reviewed, and acceptance decided upon by Township officials.



3.5 Grant Potential

There are many organizations our Parks and Recreation Committee are considering reaching out to assist in funding future projects. They include: MDOT, MNRTF, CMP, Great Lakes Fisheries Trust, Michigan Waterways, Community Foundation, Charlevoix County, local conservancy, local tribal governments, Township and private donations. Lake Charlevoix Association has been very supportive of our plans to restore the shoreline at Camp Sea-Gull and they gifted 5 hours of professional consultation from Red Twig Consulting to help move the project forward.

Our Committee and Board members all feel strongly about projects like the shoreline restoration. Becoming an environmental learning project that pulls in people from different groups and gives them a hands-on opportunity to re-engineer a high energy shoreline. This not only benefits our Park and efforts to stabilize the shoreline, but the education goes forward to rebuild shorelines of other lakes and waterways that will make a substantial difference in our ecosystem as a whole.

3.6 Charlevoix County Parks Millage Fund

At the end of 2023, tax dollars have been appropriated to fund over 65 projects throughout the County. This has resulted in new or improved recreational opportunities for residents and visitors alike.

The parks millage renewal request is for 0.15 mills for four years from 2022-26 “for the purpose of providing funds for the operation and capital improvements of the County’s parks and for funding the county program to improve other parks within the County.” Funds are awarded once annually, with an announcement of recipients being made in late spring.

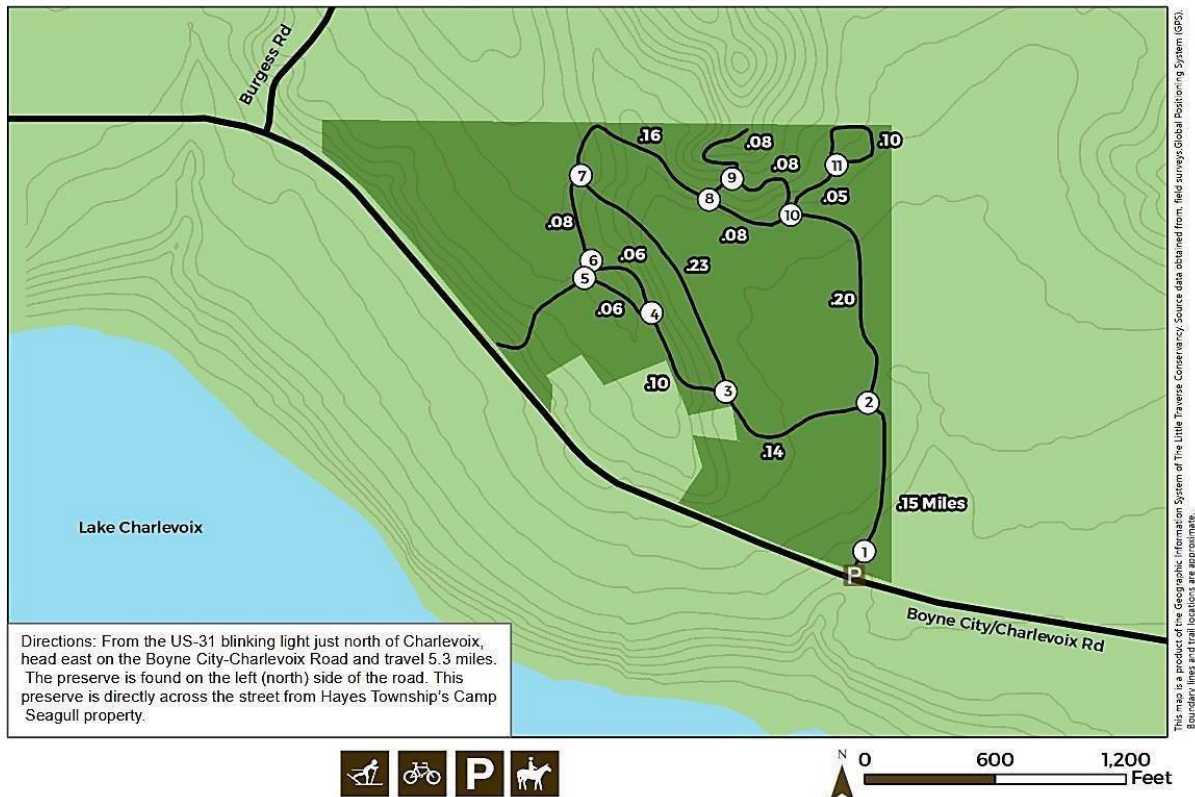

Land Description on map: Once a farm, the property includes a pine plantation, wetland/pond, open fields, and a high, forested ridge. Trails: A 1½ mile trail system meanders through the preserve, providing views of Lake Charlevoix. Cross-country ski trails are often groomed by a volunteer in the winter.

History: When the possibility of a 20-home development was raised for this property, grassroots fundraising by a neighborhood group resulted in the creation of this preserve. The preserve was named in honor of Barry Driggers who had a long conservation history throughout the country and whose family has summered in the Horton Bay region for decades. Directions: From the intersection of US-31 just north of Charlevoix, head east on the Boyne City-Charlevoix Road and travel 5.3 miles. The preserve is found on the left (north) side of the road, directly across the street from Hayes Township's Camp Sea-Gull property.

5.0 PLANNING AND PUBLIC INPUT PROCESS

Planning Process 2008 – 2023

Hayes Township put their first Recreation Master Plan in 2008. It was a large stepping-stone to the acquisition of the Camp Sea-Gull property in 2013. Since the first plan, there have been two revisions. The current draft would be the third update. All plans have had a public hearing and been recommended by the Hayes Township Planning Commission for adoption by the Hayes Township Board of Trustees.

The current five-year plan draft, 2024-2029, is a comprehensive overview of the parks and recreation areas and opportunities in Hayes Township. It also covers future plans and suggestions on how to continue to grow and improve our existing parks and recreational properties.

A public survey was released to the residents of Hayes Township during the update of this plan. The results are included later in this document. The most recent census statistics are also included in this update, to best represent the current state of our Township.





Parks and Recreation Plan Timeline 2023-24 Update

To meet new Michigan Department of Natural Resources requirements and deadlines, the Parks and Recreation Committee followed the following timeline:

- May and June 2023: The committee members all reviewed the previous Hayes Township Master Recreation Plan. The members noted the sections that needed to be updated.
- The Parks and Recreation Committee discussed edits to be made for the updated version. New renderings of Hayes Township Park Camp Sea-Gull were collaborated on from Beckett and Raeder to include in the updated plan.
- December 12th, 2023: Parks and Recreation Committee present the updated plan to the Planning Commission and request a public hearing be scheduled in a minimum of 30-days, with public notice of review and input of the 2024-2029 draft update of the Parks and Recreation Plan published to local news outlet, posted on the Township Website and a hard copy will be made available at the Township Hall and Charlevoix Public Library.
- January 16th, 2024: Hayes Township Planning Commission holds a public hearing for comments on the 2024-2029 updated Parks and Recreation Plan. Minutes are recorded of the hearing. A resolution is presented for adoption.
- January xx, 2024: Hayes Township Board of Trustees adopts the 2019-2024 Parks and Recreation Plan.
- The Hayes Township 2024-2029 Parks and Recreation Master Plan, along with supporting documents, are submitted to the Michigan Department of Natural Resources Website.

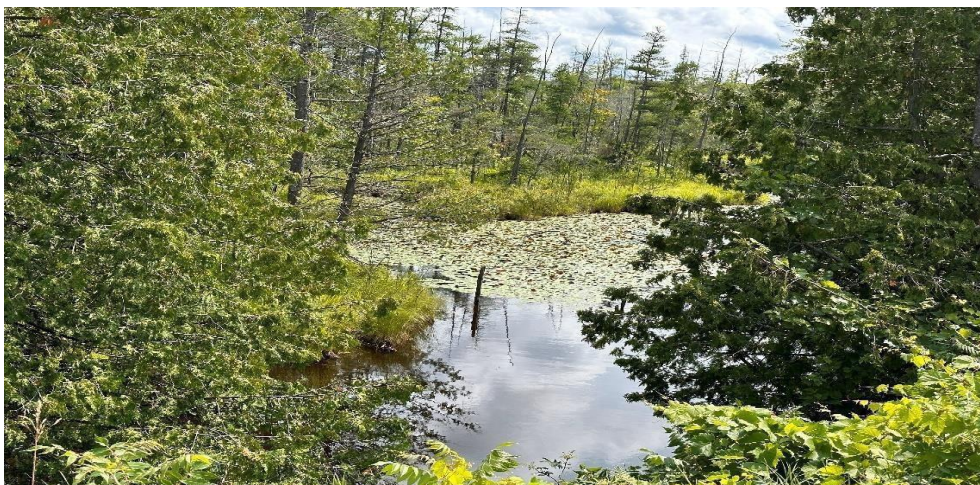


6.0 GOALS AND OBJECTIVES

Recreational Goals & Objectives

- To maintain and improve all Hayes Township recreation areas for the enjoyment of residents and visitors.
- To continue development of Camp Sea-Gull, adding amenities as well as re-imagining the current facilities to utilize their footprint and bring new life to the remaining features of the former camp.
- Restoration and bioengineering of the park shoreline at Camp Sea-Gull. Shoreline stabilization will help create a better ecosystem along Lake Charlevoix and preserve the integrity of the high-energy shore of the park.
- To work with local groups and municipalities toward completion of the Boyne City road Trail, including a trailhead for the non-motorized trail at Hayes Township Park Camp Sea-Gull.
- To increase public awareness of the parks, recreational opportunities, facilities and nature preserves, wetlands areas in Hayes Township, through the development of maps, signage and information posted on the Township website and kiosks in the parks.
- To seek grant funding for recreation improvements.
- To work cooperatively with neighboring associations, adjacent Townships, and the County to meet recreational needs of the region, including the development of water trails with support facilities on Lake Charlevoix, Lake Michigan and Little Traverse Bay.
- To continue to nurture our community, bringing residents together through activities, recreation, and events that promote enhancement of our parks and resources.

6.1 Foundation for Facilities

Hayes Township Park Camp Sea-Gull Development

Hayes Township will continue to develop a lakefront park for local use on Lake Charlevoix. The Hayes Township Park Camp Sea-Gull property was acquired with the assistance of a Michigan Natural Resource Trust Fund grant. The first phase of development of the property, which included a relocated entrance, access road, boat launch, fishing pier and toilet facilities, was completed in Phase I of construction. Ultimately the development of the property may include, but not be limited to,

- Parking area in upper park
- Buffering of adjacent properties—possibly with fence and trees
- Playground
- Pickleball Courts
- Winter activities
- Kayak launch
- Boardwalk and interpretive signage in appropriate park areas
- Covered pavilion with electricity and bathrooms/shower area
- Replanting trees
- Trail head for non-motorized trail: bike repair station, shelter, water station
- Volleyball Courts

The Parks and Recreation Committee, with the full support of the Hayes Township Board of Trustees, has begun work on planning the restoration of the shoreline at Hayes Township Park Camp Sea-Gull. Working closely with other groups in the area, under the consult of Jen Buchanan (Red Twig Consulting Firm) and her vast experience in shoreline stabilization, Hayes Township will continue taking steps forward with this project.

Renderings have been created to not only show the future potential plans for Hayes Township Park Camp Sea-Gull, but shoreline engineering as well. The next portion of this plan will show the renderings for the Upper part of Camp Sea-Gull, the lower part of Camp Sea-Gull, as well as the shoreline restoration. This will be a project that carries out over several years. The Hayes Township Board of Trustees is in tandem with the Parks and Recreation Committee on their commitment to stabilize and restore the disrupted shoreline along the bottom part of Camp Sea-Gull.

Township funds, as well as fundraising, volunteers, grants, and private donations will assist in funding this project to completion.

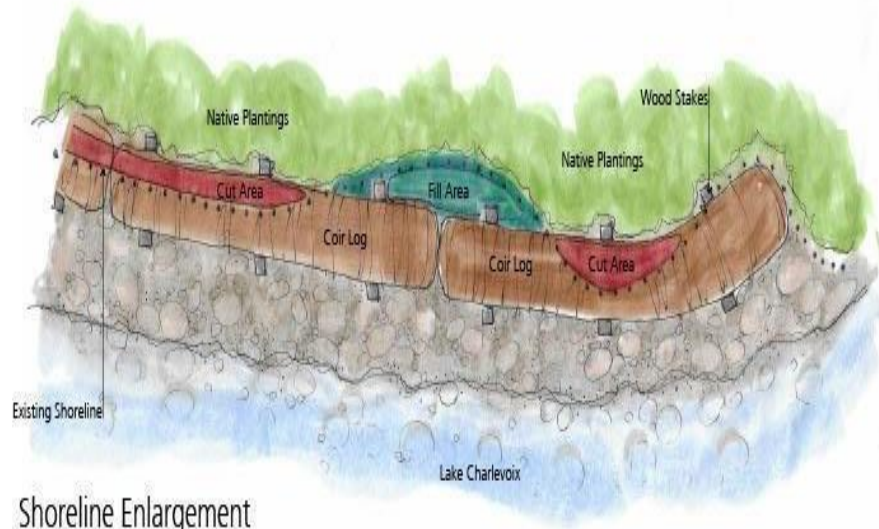

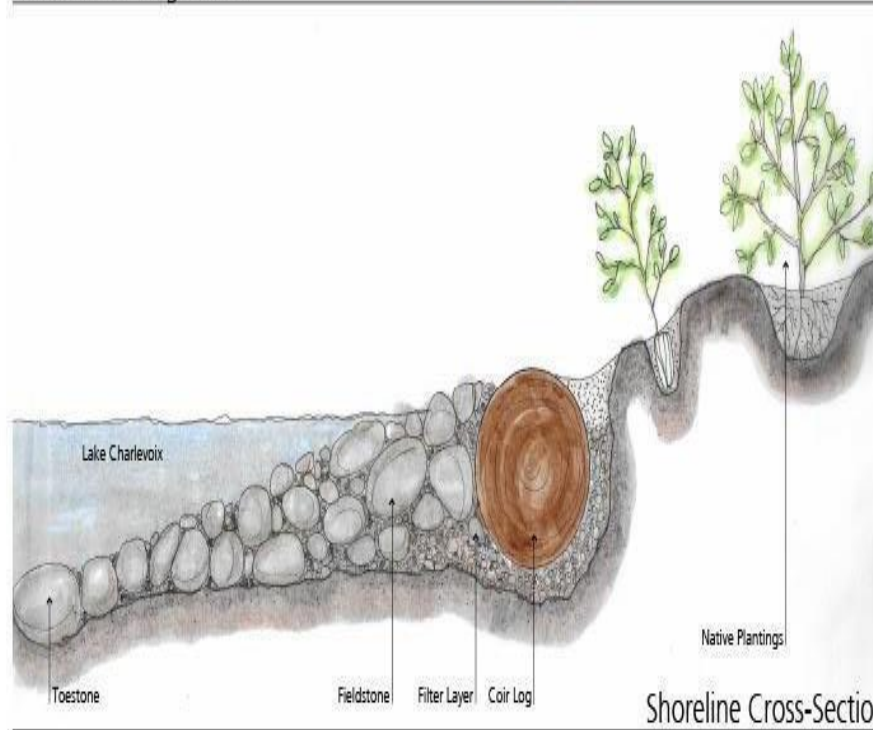

Eastern Avenue Beach Park Access Facilities

This Lake Charlevoix swimming area is a well-used park in Hayes Township. The Pine Point Association and Board of Trustees of Hayes Township have an excellent relationship and work together to keep this beautiful swimming beach in order. The deed restrictions on this park prevent any buildings or restrooms from being built. Keeping the area groomed, safe, with picnic tables in good condition, and regular seasonal maintenance, are the main goals of both the Township and association.

Eastern Avenue Beach



The yearly maintenance for this park includes cleaning/grooming sand twice, keeping lawn/plants groomed, picnic tables in safe order, and having the buoys put in the water/taken out of the water at the beginning and end of each season. Any safety issues or concerns get turned over to the sheriff's office and/or Coast Guard.



Direction for New Non-motorized Routes

There is a need and interest in providing non-motorized pathways throughout the Township including along the Boyne City-Charlevoix Road to connect into a regional trail system. The trail along Boyne City-Charlevoix Road is a project of the Charlevoix County Planning Commission. The schedule calls for five separate phases of construction. The first two phases, segments at each end, have been completed. The portion of the trail which will connect directly with Hayes Township Park Camp Sea-Gull is phase Four. The completion date has not yet been established. Trails throughout northern Michigan are used extensively both by residents and tourists. The desire for other hiking trails, new EBike types and uses, x-country ski and snowshoeing trails is currently being explored and may be appropriate on future township properties.

Direction for Other Trails: Water Trails and Snowmobile Connector Routes

Hayes Township is bounded by the Little Traverse Bay of Lake Michigan on the north, and Lake Charlevoix on the south, thus presenting incredible opportunities to partner with others to be part of a larger system of water trails, both in Little Traverse Bay and within Lake Charlevoix.

There are several snowmobile routes throughout northern Michigan, but these pathways generally do not extend into Hayes Township, except where snowmobiles can ride within county road rights-of-way. To improve safety and to better serve the residents and the region, the Township proposes to work with local groups to identify appropriate connector routes through the Township to provide access to a broader network of trails.

Foundation for increased Recreational Site Signage, Maps and Information

Northern Michigan continues to see an increase in both visitors and full-time residents. As our parks and recreation areas have an uptick in usage, the township wants to make sure that we offer information to all guests. This information includes not only locations, but available amenities as well.

Adding both informational and interpretive signage is an excellent way to achieve this communication. The Parks and Recreation Committee will work to add appropriate signage within township parks each season where time and resources allow. They will also share up to date information on their website and through all township publishing.

Historical Markers

The Michigan Historical Marker Program was established by the legislature and governor in 1955, years before others. Since then, more than 1,700 have been placed across the state making Michigan's one of the premier marker programs in the nation. Each marker reflects an important story of a place, an event or a person. A marker dedication ceremony is an event of commemoration and even celebration that introduces a lasting resource for tourism, education, and community heritage.

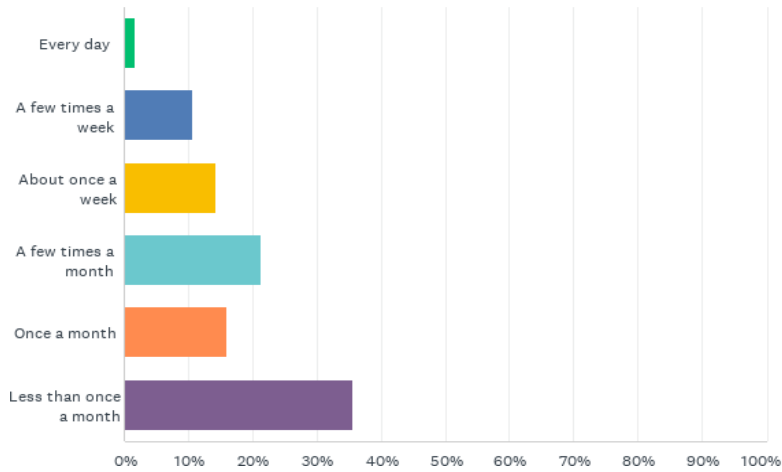

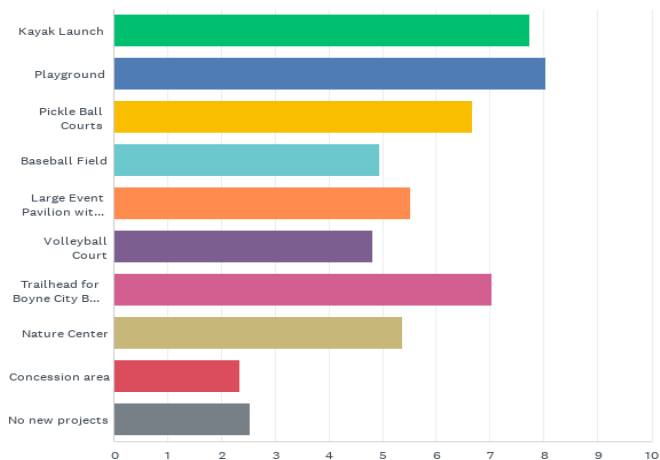

Q1 How often do you visit Hayes Township Parks?

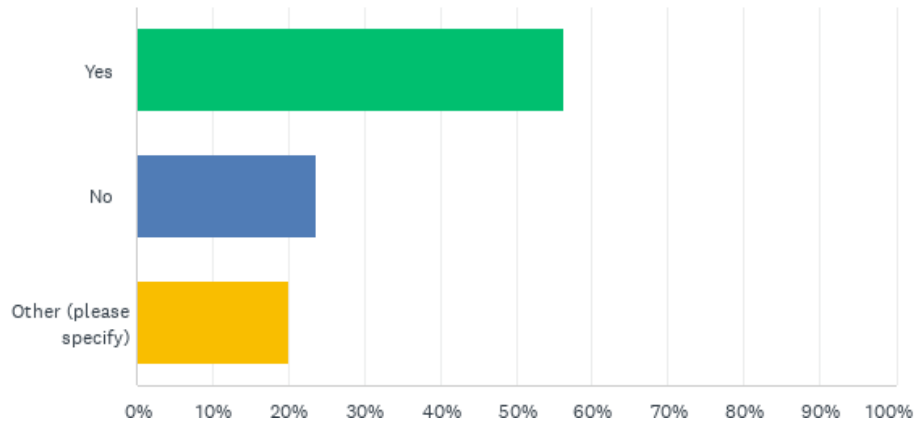


Q3 Please rate these projects in order of your level of support for Hayes Township Park Camp Sea Gull? (1-support the most, 10-support the least)

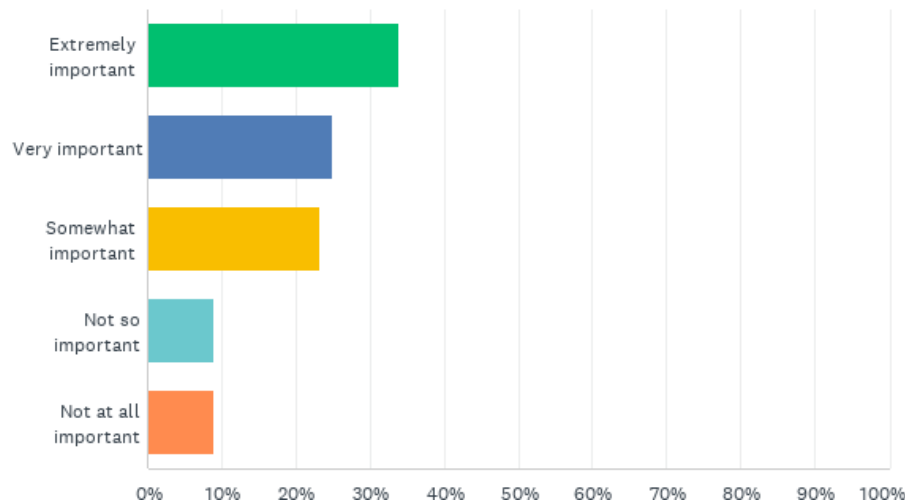




Q4 Are you generally satisfied with the development of the township parks?

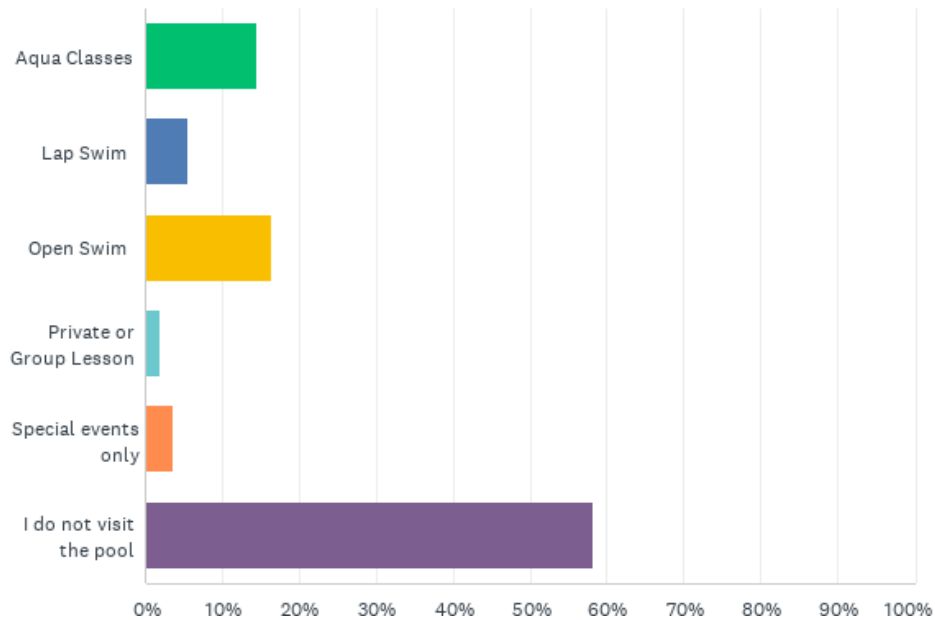

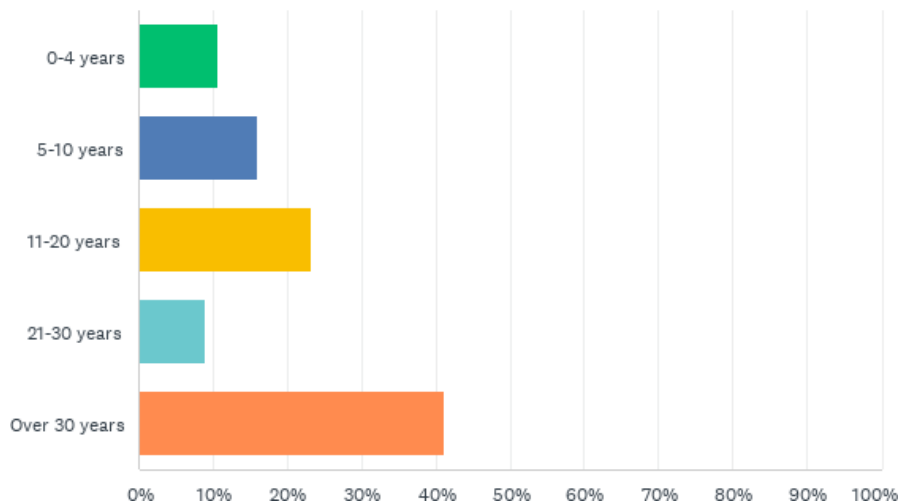

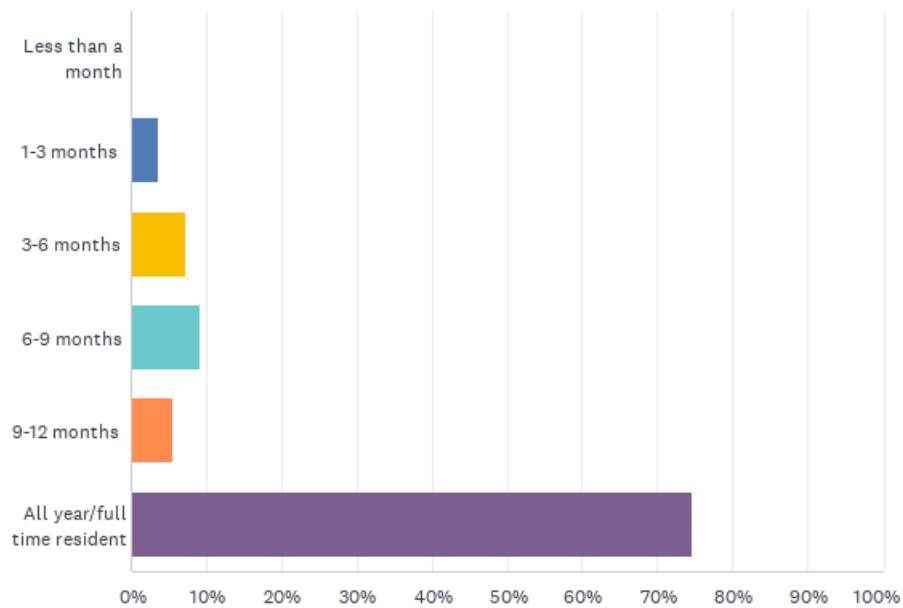


Q7 How long have you lived in Hayes Township?

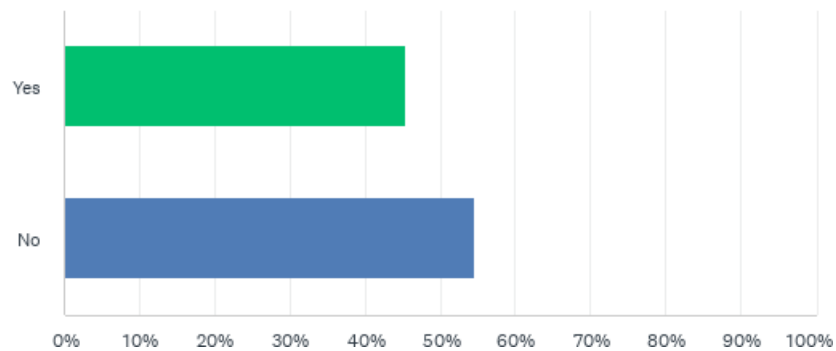




Q8 How much of the year do you live in Hayes?

Make the parks safe

On the list of projects we are asked to rate, you do not provide the option of a swimming area, which was asked in the last survey, and was rated as one of the top 3 priorities by residents, with 49% strongly agreeing and another 29% agreeing, for a total of 78.9% agreeing. Only picnic area (79.4 %) and restroom (83.7%) ranked higher. Without providing this option as a ranked choice, you are not allowing the people to choose it. What is on the Master Plan depends on results of the survey. You also don't ask about restrooms. (the pit toilets are not adequate) nor about tennis courts and winter activities, as before. This is a fixed list that will get skewed results. This survey is being conducted without any random mailing to residents, therefore it will not be statistically valid. The township re-do this survey. Parks and Rec meetings should be held by Zoom. While pretty annual flowers are nice for residential homes, they have no place on the natural lakeshore or within the shoreland protection strip. The Camp Seagull shoreland should be an exemplary model of shoreland protection. Also, the presence of the caretaker's house is too residential in appearance and not blending in with the park. The aesthetic is

one of coming into someone's private property. The caretaker's residence, if this is to continue, should be subtle and secondary to the park's features, shielded from public view. It is too much like an R-1 zone, not a park. A building or outdoor amphitheater that can be used for events such as music concerts, environmental presentations, and nature activities for kids, would be a wonderful addition. With a swim area, there should also be a facility suitable for changing clothes and a pit toilet facility is just inadequate. Remove all the concrete on the land, and in the water. The shale wall still looks to be a very big problem. The parks and rec committee should be broadened to include other people and there should be term limits set. There is no transparency about what this group is planning, as decisions are made in this advisory board, then presented to Board of Trustees as a done deal and without any discussion at all, the Board adopts whatever the parks and rec board pre-decided. That means no opportunity for dialogue by trustees or by the public. This has to stop. The budget for parks and rec is also a mystery. How much money is being spent on Beckett and Raeder doing all this consulting work and when and by whom are those budget decisions being made? None of

this has been before the public. \$300,000 for pickle ball courts is a lot of money for an amenity that never even appeared in the last survey or in the Master Plan.

There is no thought given to recreational needs in the northern part of our community.

More recreational opportunities could be made on township owned land near the township hall. Bay Shore's park needs actual budget dollars to develop it, not volunteers keeping up the bare minimum effort. It's insulting to the public to not even have what they wanted most in Camp Seagull, a place to swim, even on the Parks and Rec board's radar in this survey. No significant progress has been made at the park since the boat launch went in. It's a great thing to have a natural park on the lakefront. Making it something special and keeping it natural is what will serve residents for decades to come.

The recreation board is composed of people who are not for the park as well as the board, we want the board to make the decisions about the park not the park committee as they are only an advisory committee, also have heard that the rain gardens are not sufficient, I do not believe this is true. The township needs to focus on their jobs as board not trustee members and not hire out all the thinking and planning and do it themselves. The township would not have to spend so much

money and ask for a millage increase if the board and the planning Commission would do their jobs.

We need more seating. Access to the lake at the swimming area needs improvement. A safer ramp would be great. The addition of expected basic amenities like picnic tables and chairs/benches to the park has been way too slow. I am not in favor of a park millage. The county already collects one. I'd rather say what I think we need, not rank order. There should also be a category of "other". I had to rank things we do not need i.e. playground, volleyball, baseball, concessions, nature center, and I'm not sold on pickle ball courts. They are very expensive to build. I am afraid they are fad that will fade away and also only a few people can utilize them at the same time.
